(21/085.01) Councillors had **OBJECTED** to the below application.

Application 20/03482/F - 66 Bicester Road. We continue to object to this on the basis of over development.



(21/065.02) – St Frideswide Farm - Residential development at St Frideswide Farm in North Oxford. (adjacent to our parish)

The site is allocated for residential development in the Oxford Local Plan 2036 and will provide housing, including affordable homes, to meet Oxford's housing needs.

How is the already crowded shared bike lane with the bus lane going to be managed etc. Cllr S Wilson-Higgins will prepare a statement.

(21/065.03) Application 20/03398/LB – **NO OBJECTION** Conversion of traditional lift bridge to manual hydraulic control at Wolvercote Tilting Bridge, 300 metres SE of Dukes Cut, Oxford Canal, Gosford.

21/086 To receive reports from Councillors, County and Other contributors representing the Council on outside bodies and meeting

(21.086.01) Cllr Billington: A party was reported in Gosford on New Year's Eve, over 400 people attended despite Covid 19 restrictions. 30 police were called and the road had to be shut as a result. This was unacceptable and questions are raised on why the police did not disperse it sooner.

(21.086.02) Cllr Billington: Bad flooding in the areas over the Christmas period. Mill Street just outside of the parish had problems.

(21.086.03) Cllr M Billington: The budget will be finalised for county soon.

(21.086.04) Cllr N Simpson – schools are closed due to Covid. No further updates regarding the schools. (21.086.05) Cllr N Simpson - The testing facility is working well. This remains at Oxford Parkway.

(21.086.06) Cllr S Wilson-Higgins carried out a litter pick over Christmas. There were 3 bin bags full in one area. We need to do another litter pick as soon as possible (once Covid allows).

(21.086.07) Cllr C Matheson attended the railway meeting with Yarnton PC. The schools need to tell railway company how they feel about the closure of Sandy Lane. Cllr Simpson is still waiting for a response from Gosford Hill School.

(21.086.08) Cllr C Stayt – we did need to release our Spring Newsletter in February (late Feb) – to be discussed next meeting. The clerk will start putting a base to this together.

(21.086.09) The clerk will ask Yarnton clerk for the national rail presentation to include in our newsletter.
