22/233 Update on progress from the minutes held in on 6th September 2022 and Matters Arising The minutes if the meeting on 6th September were approved and no matters arising. There was no October 2022 meeting.

22/234 Reports

(22/234.01) To receive reports from District and County Councillors

Cllr Ian Middleton community governance review has gone through. It included that Kidlington and Gosford are not merging.

Fracking – Cherwell is now a frack free zone.

Water Sewage transparency – If there is going to be any building companies need to advise how much sewage there will to the water companies.

Parking standards policy – where there are conversions, fewer parking spaces are on developments which is causing parking on the roads / verges. It is possible that more controlled parking zones may be required in the future.

A34 noise – motion at county. Suggestion to lobby government to put in sound barriers along it. Motion to support and install greener energy efficiency.

50 million gap with Oxfordshire County Council at the moment which is being looked at by OCC. *Cllr C Stayt* – OUFC have sent an update with their survey results. 10% response rate received. www.oufcstadium.co.uk has further info. Planning information is expected around the New Year. Friends of Stratfield Brake meeting held with KPC – there might be some reluctance for decision making prior to elections. Discussions around having a parish poll, needs further discussion and will link with KPC if a poll is done so whole area is covered.

Cllr Prestidge – Various places offering warm spaces in Kidlington.
