CONSULTATION – Water Eaton Lane (Gosford) Proposed Parking Restrictions

Following earlier consultations carried out in March 2017 (details available here) & November 2017 (details available here), which resulted in the recommendation/decision at the time to only proceed with the implementation of 'No Waiting at Any Time' (double yellow lines) restrictions as advertised and not proceed with the timed waiting restrictions (single yellow lines), we are now writing to seek your views on the proposal to introduce 'No Waiting Monday to Friday 9am to 5pm' (single yellow lines) on both sides of Water Eaton Lane in Gosford. The proposals are being revisited as a result of the levels of unregulated parking along the lane, and will also help to prevent parked vehicles obstructing visibility and restricting the safe passage of traffic along the lane, as well as ensuring agricultural & emergency vehicles are able to travel unhindered along its length. Specifically the measures comprise of introducing timed parking restrictions ('No Waiting Monday to Friday 9am to 5pm') on both sides for approximately 355 metres southwards from the existing double yellow lines at the junction with Bicester Road. In light of this, please find the following consultation documents attached:

- Statement of Reasons,
- Consultation Plan,
- Draft Traffic Regulation Order.

The proposed Traffic Regulation Order are due to be advertised in the Oxford Times newspaper today; Thursday 20th May 2021, and details are also available to view on the Councils consultation pages at the address below:
